BRANT FOOD FOR THOUGHT

NETWORK OF GIVING

Every year thousands of people in Brantford, Brant County and Six Nations of the Grand River give generously to the Brant United Way. Here's how you can give:



PERSONAL GIFT

These are one time donations and may include cash, cheque, or credit card payment.



RECURRING GIFT

These are ongoing donations made up of smaller payments scheduled over time. This may include credit card, bank, or payroll deductions through your workplace



PLANNED GIVING

These are gifts scheduled to take place at a future date. This may include estate planning, bequests, or donations of stocks or bonds.

TAX SAVINGS

A gift to Brant United Way may qualify for a credit against federal and provincial taxes.
